Progress update

At the moment, it will probably look like little is happening, but we are working hard to get ready for the work that is required at Douglas House. Here is an example of what we have been doing...

We will shortly start the process of appointing a contractor, and we will be working with consultants to assist us with this. The contractor will be required to design a solution and replace the cladding with a new system that adheres to current regulations for buildings over 18 meters. They will also apply for planning permission, if required, which must be granted before the work to strip off and replace the existing insulation can start. Our target to complete the works at Douglas House is late 2024 / early 2025, but we will keep you updated.

We are applying to the Cladding Safety Scheme for funding to support us with the cost of the works to replace the existing cladding as advised by the Fire Risk Appraisal for External Walls (FRAEW). We are currently gathering the information needed to submit an application to Homes England. They will then assess it and make a decision.

In addition, Douglas House has been registered with the Building Safety Regulator. From 1 October 2023, they became the Building Control Authority and all buildings over 18 meters needed to be registered. Information on the structure and fire safety for the block was provided as part of the registration process.

External wall insulation at Parson Street, Pellew House and St James House

We wanted to update you as we recently had an independent Fire Risk Appraisal of External Walls (FRAEW) carried out at Parson Street, Pellew House and St James House. Following this assessment, we have received a report for each building, which confirms that as they are all under 18 meters in height, there is no requirement to remove the external wall insulation. Some minor remedial work has been identified, which will be completed over the next few months. We know questions have been asked as to why Douglas House is having its external render and wall insulation removed. As we said in our letter to all residents in April, it is down to the building being just over 18 meters, therefore classed as 'high-risk', and the recommendations from the FRAEW to meet the Building Safety Act 2022 and the Fire Safety (England) Regulations 2022.

Resident Engagement Strategy for Douglas House

The Building Safety Act 2022 requires us to have a Resident Engagement Strategy for all buildings over 18 meters high. The strategy outlines our approach to fire and building safety at Douglas House, how we will communicate with tenants and leaseholders and how you can work with us when making future decisions.

You may remember that we sent you a survey in September - thank you to everyone who took the time to respond. This has helped us shape the first version of the strategy, which will be updated as the work at Douglas House progresses.
